Dale Similton has 27 years of teaching & coaching experience at Central Academy at Lake Park, Charlotte Latin, Covenant Day, Metrolina Christian Academy and at Union Academy. At Charlotte Latin, Similton served on the coaching staff of the varsity boys and girls teams during his tenure. As head coach of the 8th grade Boys Basketball team, he accumulated a record of 58-11, winning the conference three years in a row. As head coach of the Covenant Day Boys Varsity Basketball team, he led the team to its first trips to the state play-offs, with the team setting over 20 (individual and team) records during the 2007-2008 season. His Central Academy varsity boys won five conference championships and four post-season tournament championships in eight years, making school history. He began serving at Union Academy in 2019, as the Varsity Boys Basketball Assistant Coach.

A multi-sport athlete at South Mecklenburg High School, Coach Similton attended Mars Hill University on a football scholarship. While there he set several records as a receiver, won a football championship and earned an All-American honorable mention. In 2016, he was inducted into the Mars Hill Football Hall of Fame.

Committed to his faith, Coach Similton is passionate about helping young people grow into an understanding of God's calling on their lives. Coach Similton is assisted by a staff of adult and young adult athletes and coaches who have a heart for working with youth.
